CFSO is offering FREE tax preparation services for low income individuals and families with simple tax returns, if you meet the following eligibility criteria.

1. Immigration Status in Canada: Permanent Resident, Live-In Caregiver, Convention Refugee and Gaza Prog., Hong Kong Pathway
2. Annual Gross Income:
 - Single: Up to \$45,000
 - Couple/Single Parent with a child: Up to \$55,000
 - \$5,000 for each additional child
 - E.g: Couple with one child: Up to \$60,000
 - Bank Interest: Up to \$1,200
3. No Rental Income, Investment, Business, Self-Employment, Foreign Income or Expenses to claim
4. Not applicable to deceased person or an individual who filed for bankruptcy
